

# **LIGHT MEMBERSHIP**

**Regulations 2026** 

### A. ANNUAL MEMBERSHIP: 749 €

Light Member: 674 €Federal Card « C »: 75 €

#### **B. INCLUDED BENEFITS**

- 5 indivisible 18-hole rounds **OR** 8 9-hole rounds
- Access to the driving range 7 days a week
- Federal Card "C"
- Authorized to participate in competitions, weekends only (upon payment of a greenfee)
- Handicap management

## C. USAGE

You will receive a package of 5 18-hole rounds or 8 9-hole rounds, to be chosen at registration (18-hole rounds are indivisible).

It is mandatory to book your tee time and check in at reception before playing.

Rounds will be automatically deducted via the BEgolf app with each reservation.

Once your package is used up and you wish to continue playing, you must pay your greenfee exclusively online at the time of booking. At this point, a greenfee subscription cannot be used.

If you cannot honor a reservation, you must cancel it; otherwise, a voucher will be deducted. When you cancel a reservation, the voucher is released.

If a greenfee has been paid online and you wish to cancel the reservation, you will have two months to reschedule. The cancellation must be made at least 2 hours before your tee time.

If you chose 9-hole vouchers but wish to play 18 holes, you will be asked to pay the greenfee online.

A lesson with a Pro can be taken on the course, either by deducting a round or paying a greenfee.

You may invite external visitors to the Club, but they will not benefit from the guest rate. Additionally, you cannot benefit from the guest rate when playing with another Bawette member.

Regarding competitions, you are only allowed to play those held on weekends, but you cannot use your package greenfees for this purpose. You must pay the greenfee online at registration.

Participation in the interclubs and the Club Championship is not allowed.

The price for a bucket of practice balls is €1.40 for 25 balls.

# **D. CONDITIONS**

The Light Membership is valid from January 1 to December 31. In case of registration during the year, no prorated annual fee will be applied.

Any voucher not used before December 31 will be lost and cannot be carried over.

This status is granted for a maximum of one year. Renewal is subject each year to the Club Management's approval: at any time, the number may be limited and the fee may be indexed. The Club may stop offering this light membership or refuse to renew a problematic membership at any time, without justification.

For so-called "permanent" members wishing to subscribe, this will result in the loss of that status and its associated benefits, such as the preferential rate, couple's discount, and seniority.

For so-called "temporary" members, no couple's discount will be applied if one or both partners are Light Members.

In case of non-compliance with these conditions, the member must pay the due greenfee plus an additional greenfee as a penalty and also pay a deposit of €150. In case of repeat offense, the membership will be immediately canceled and the deposit will not be refunded. The member must either pay for a new Light Membership or will be excluded from the Club.

The Light Member agrees to strictly comply with these regulations and all other Club rules by signing a membership application.

The Club Management is the only authority able to interpret or modify these regulations if necessary.
